

Privacy Policy

Okinawa Adventure Travel Inc. (hereinafter referred to as "the Company") has established the following privacy policy (hereinafter referred to as the "Policy") regarding the handling of personal information and complies with the Act on the Protection of Personal Information (hereinafter referred to as the "Personal Information Protection Act") and other related laws and regulations. If you wish to use any of the various services on this website or any of our services related to travel services (hereinafter referred to as "the services") under the Travel Agency Act, please provide us with your personal information after agreeing to the following.

1. The Personal Information We Collect

We collect personal information to the extent necessary and by appropriate means after specifying the purpose for which the information will be used.

2. Purpose of Use of Personal Information

We will use personal information only within the scope of the following purposes of use and the separately notified or publicly announced purposes of use unless otherwise permitted by law.

(1) Information obtained from customers in connection with the services

- Conclusion and fulfillment of agreements with customers regarding the services
- Confirmation of the customer's identity or their representative
- Fulfillment of agreements with contractors or business partners necessary to fulfill agreements with customers regarding the services
- Implementation of questionnaires or campaigns related to the services
- Sending of email newsletters, direct messages, etc., associated with the services
- Responses to inquiries about the services
- Data analysis, in addition to planning and development related to the services
- Proposal of various services tailored to the customer's age, gender, hobbies, or other attributes.

(2) Information obtained from business partners in connection with the services

- Conclusion or fulfillment of agreements for outsourcing or business collaboration with business partners required to provide the services

(3) Information obtained in connection with the Company's recruitment activities and human resources management

- Provision of information related to the recruitment by the Company or acceptance of applications or inquiries
- Ongoing communication by the Company and provision of information about the Company to applicants or those given tentative job offers
- Personnel management and training after the employment decision is made by the Company
- Other purposes incidental to the Company's recruitment activities and personnel management

3. Management of Personal Data

The Company takes necessary and appropriate measures to prevent personal data breaches, loss, or damage. In addition, we will exercise necessary and appropriate supervision over our employees to ensure the safe management of personal data, and in the event that we outsource all or part of the handling of personal data to an external contractor, we will exercise necessary and appropriate supervision over the contractor.

4. Provision of Personal Data to Third Parties

The Company will not provide personal data to third parties except with the prior consent of the individual when required by law or when permitted by law.

5. Integration with External Services

The services can connect and integrate with accounts in external services operated by third parties with the user's consent, but please note that information provided by the user to external services is not under our control and is subject to the terms of use and privacy policy of the external service and our terms of use and privacy policy separately.

6. Use of Statistical Information

The Company may create statistical data based on the personal information it receives, but it will be processed in a way that prevents the identification of individuals. The Company may use statistical data that does not disclose individual identities without restriction.

7. Requests for Notification of Purpose of Use, Disclosure, Correction, Suspension of Use, etc. of Personal Data

If we receive any of the following requests from an individual regarding their personal information in our possession, we will respond to the request in accordance with the provisions of the Personal Information Protection Act after confirming that the request is made by the individual or their representative.

- (1) Notification of Purpose of Use
- (2) Disclosure of identifiable personal data held by the Company about the individual
- (3) Correction, addition, or deletion of identifiable personal data held by the Company about the individual
- (4) Suspension of use, erasure, or cessation of provision to third parties
